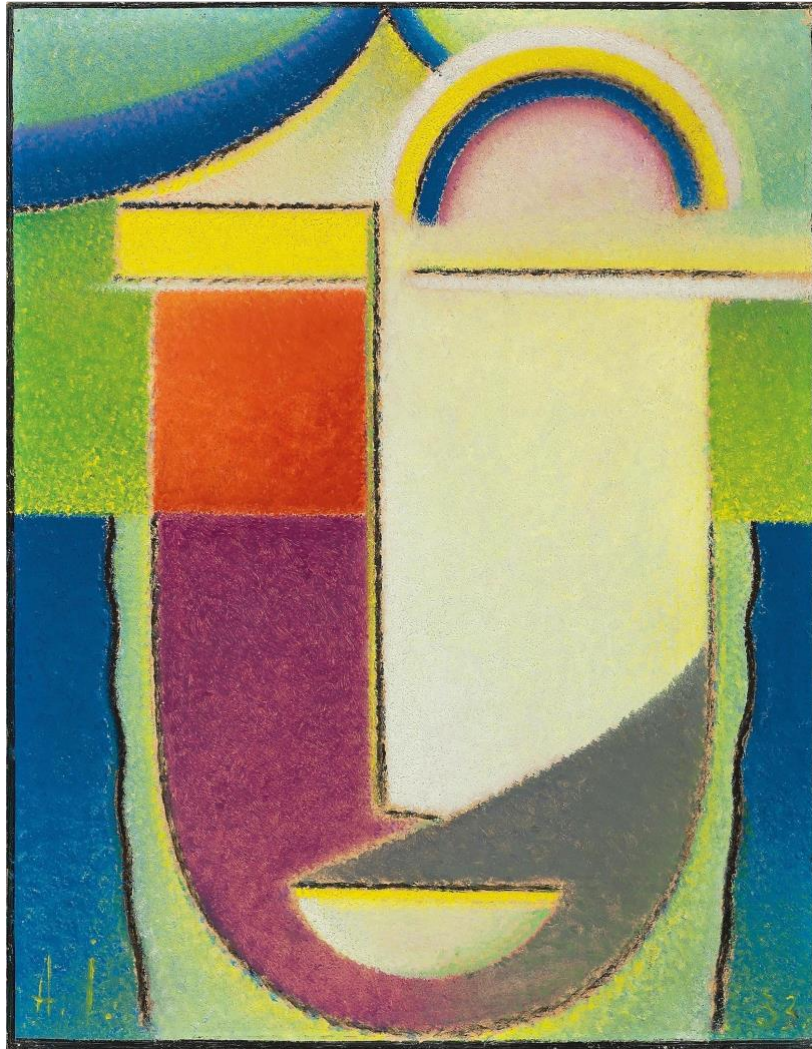

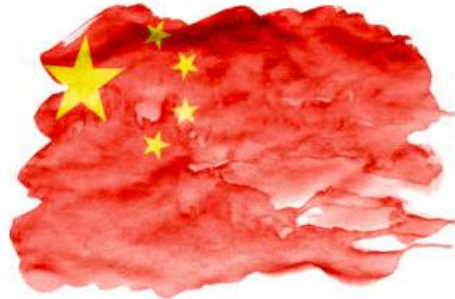

ACCESS Health China



ACCESS Health China is committed to promoting health system transformation in China through innovation. Our work focuses on three aspects of innovation, including health service, health financing and payment, and health technology. As a leading think tank and catalyst in healthcare innovation, ACCESS Health China has established connections with more than sixty organization partners and hundreds of individual industry leaders.

2020 has been a difficult year for the whole world. ACCESS Health China co-organized a two-month training on public health management addressing the COVID-19 pandemic with China Primary Healthcare Foundation. Although the global economy has ground to a halt, the ACCESS Health China team promoted several vital collaborations with organizations like Ping An Smart City and Pfizer China. The team concluded the year with a closed-door seminar for Chinese biopharma companies with Singapore Economic Development Board, providing insights and creating networks for business opportunities.

The Chinese research team also had a highly productive year. The team's published reports included: *Integrated Care on Chronic Diseases in Asia-Pacific Countries* supported by Asia Pacific Observatory on Health Systems and Policies (WHO) — published in *International Journal of Integrated Care*, *The Transformation of Commercial Health Insurance in the Context of "Healthy China 2030"* a white paper on Commercial Health Insurance (CHI) supported by and in collaboration with Pfizer, and *Tackling Covid-19 Pandemic Through Integrating Digital Technology And Public Health: Linking Experiences in China to The World* with support from The Rockefeller Foundation.

ACCESS Health India



In response to NITI Aayog's report: "Health Systems for a New India: Building Blocks - Potential Pathways to Reform," released in November of 2019, ACCESS Health India embarked on the first important milestone of policy research to redesign India's health system. Additionally, the India team had the opportunity to work on implementing a systems-level transformation in a population cluster of Al-Qassim in the Kingdom of Saudi Arabia.

The India office continued to focus on designing the India National Digital Health Blueprint which later led to announcing the National Digital Health Mission to implement standards-based interoperable national health data. In implementing PMJAY, a public health insurance program covering about 500 million people, the India team aided in providing technical support to state health authorities throughout the COVID-19 pandemic.

In 2020, InOrder, the institute for health systems strengthening, was initiated and designed around a five subsystem schema to build five Centers of Excellence: Centers for Health Systems Governance, Healthcare Provider System, Health Payer System, Health Information System, and Public Health System. These five systems have been built in accordance with five workstreams: research, capacity building, advisory and technical support, advocacy, and awareness.

ACCESS Health India is also creating collaboratives to build national-level technical capacities in health systems. In doing so, ACCESS Health India became the founding secretariat of the India Health Systems Collaborative (IHSC) which brought together leading researchers in a wide range of public health systems onto a singular platform to generate evidence that guides health policy at national and state levels.

By 2021, ACCESS Health India will witness the expansion of work in areas ranging from universal health coverage, innovative financing, leadership development, and more. The State of Telangana also offered the India office an opportunity to test various strategic interventions in organizing healthcare provision to its 40 million people to transform it into a paragon healthcare system for the country. In the continual drive to strengthen fractured health systems, ACCESS Health India aims to deepen their capacity and become self-sufficient in journeying towards living out the mission of ACCESS Health International.

ACCESS Health Philippines



Due to the COVID-19 pandemic, many of ACCESS Health Philippines's projects and activities transposed to an online setting. Nevertheless, the office continued to engage in valuable work and complete several critical projects. Through the course of 2020, the Philippines team conducted a study on the country's readiness for vertical integration of health services for a development lender; surveyed a multi-country demographic on integrated care for chronic diseases for the Asia-Pacific Observatory; and hosted a Child Protection Forum for the Consuelo Foundation. Offline, ACCESS Health Philippines worked on the TB Reach Project, which opened a second clinic in Mandaluyong City to extend the availability of private-sector TB care complementing the broader national effort.

Despite the many setbacks the pandemic caused, 2021 has started promisingly for the Philippines chapter. The office continues to work on an evaluation of the Magna Carta of Public Health Workers and a study on trends in bilateral health cooperation for the Philippine Council for Health Research and Development. Another study in the process of completion is an appraisal of health researchers' use of research-based evidence to influence public health policy for the Global Development Network.

As ACCESS Health Philippines's local office becomes more integrated with ACCESS Health's wider Southeast Asian initiatives, the office has the flexibility to research the status of eHealth in the Philippines for multilateral development agencies and technology solution providers. Additionally, the Philippines team is working with a pharmaceutical concern to emphasize bone health. Through the engagement in these projects and initiatives, ACCESS Health Philippines aims to expand its capabilities to better meet the requirements of existing and prospective partners.

ACCESS Health Singapore



ACCESS Health Singapore spent 2020 strengthening its tenet of building resilient, digitally enabled, and affordable healthcare to outlast the devastation of the COVID-19 pandemic. Upon pivoting away from busy travel schedules, the office focused on tailoring their programs and messaging to respond to pandemic-related challenges, upscaling their impact in ASEAN, forming and maintaining new partnerships, and reflecting on strategies and business processes.

The Singapore office of seven grew into a vibrant team of 14, as they merged with the ACCESS Health Philippines office, deepening their ties with governments and multinational organizations in the region. To keep up the pace with Fintech for Health projects and expanding the reach and knowledge base in the markets, the Singapore team hired consultants in Nepal, Vietnam, and Malaysia.

The Startup Alliance program has been redesigned and relaunched, enabling mentorship and connection with more than ten startups in the region. ACCESS Health Singapore has hosted or spoken on panels for over 25 webinars and events centered around the focus areas of health systems strengthening, digital health, and innovative financing. The Singapore team posted five Fintech for Health blogs, co-authored three thought pieces, and published one report in partnership with the Singapore government.

In 2021, ACCESS Health Singapore plans to add to their consulting staff, publish their Fintech for Health whitepaper, further expand existing programs, and spearhead new initiatives on the agenda.

ACCESS Health United States



The United States chapter of ACCESS Health was severely tolled by the COVID outbreak as the office in New York became one of the early epicenters of the pandemic. Therefore, the US efforts have been pivoted towards raising awareness about how individuals could protect themselves against the virus. Articles and information to educate people on mask-wearing, social distancing, and testing have been released. Alongside these articles, were more detailed reports on what policymakers and healthcare leaders needed to do to protect the public regarding handling testing regimes, warning against economic and school reopenings, and how vaccine distribution programs should operate. Additionally, the US team released several COVID-19 related publications: A Family Guide to COVID, The COVID Back To School Guide, and The COVID Commentaries.

In 2021, ACCESS Health plans to focus on helping the US alongside other countries rebuild their health systems to be better prepared for future pandemics and health crises. As mutant variants of the virus spread globally and potentially evade the effectiveness of vaccines, the US office aims to be vigilant in its efforts to restore society to its normal state. Accordingly, the team plans to release monograph publications to further chronicle their collective COVID-19 efforts and experiences, with the first release being: Variants!.
