

ACCESS Health China



2021 was a significant and productive year for the China office. To date, the team has worked with over 85 public and private sector partners, over 45 startup alliance members, organized more than 16 major events, and published over 20 industry research reports. Their work has focused on health financing, health service delivery, biopharma ASEAN market expansion, digital technology, and aging.

In early 2021, the China office organized and hosted the 4th Annual International Healthcare and Finance Forum, exploring health insurance reform and health payment innovation. Another key milestone was the launch of the China Primary Care Foundation Multi-layered Medical Security System Promotion Committee. In late 2021, they held the inaugural Annual China Health Service Delivery System Innovation Forum, People-Centered, Integrated Care (PCIC). Over 70 distinguished guests from policy and academic think tanks, intragovernmental organizations, multi-lateral developmental banks, and healthcare organizations participated in the forum. Over two million attended online, drawing much-needed attention to the importance of health service delivery. In addition to organizing topical events, the team also produced many research reports.

ACCESS Health India



With India reeling from the impact of the Delta variant in 2021, ACCESS Health India launched the Global Learning Collaborative for Health Systems Resilience (GLC4HSR) with support from the Rockefeller Foundation. The <u>GLC4HSR</u> acts as a global community of health systems experts who share knowledge and best practices to build resilient health systems that can endure pandemics and other crises. The platform fosters collaboration between technical experts, physicians, governments, the private healthcare industry, academic and research institutes, and development agencies.

ACCESS Health India and InOrder partnered with the government of Telangana, a progressive state in South India, to strengthen health systems across the State. The initiative focused on improving health information systems, acute care management, the integration of primary health care with hospital-based care to ensure continuity of care, access to diagnostics and drugs, and human resource development.

ACCESS Health India also continued to work with various stakeholders to contribute to the evolving national digital health ecosystem. This was accomplished by mentoring various start-ups, conducting focus group discussions to align key stakeholders around the Ayushman Bharat Digital Mission (ABDM), contributing to the technical architecture of its core building blocks, and undertaking implementation research to inform mission management teams.

ACCESS Health India has also partnered with different educational institutions to develop a number of educational resources on data management and analytics, and health informatics to support healthcare providers.

ACCESS Health India will continue to strengthen its expertise around governance, payer, provider, public health, and information systems in 2022. This will be accomplished through further research, capacity building, consulting, technical support, advocacy, and raising awareness.

ACCESS Health Southeast Asia



ACCESS Health Southeast Asia had a whirlwind of a year, hosting and speaking on panels for over 23 webinars and events centered around health systems strengthening, digital health, and innovative financing. The office launched two whitepapers in 2021; Breaking the health-poverty trap: How fintech can improve access to healthcare in Asia and Strengthening UHC in Asia: Opportunities for innovation in private health insurance.

They hosted their inaugural Startup Alliance digital health accelerator program, helping to mentor and guide 10 startups from around the world and providing each startup with the opportunity to pitch their ideas to investors.

2021 also saw a greater expansion of the Fintech for Health initiative, with partnerships launched with BIMA in Bangladesh and with Wahed Investment in Malaysia. They were also invited (together with Singapore's Economic Development Board and Enterprise Singapore) to co-host a Fintech for Health roundtable during the Singapore Week of Innovation and Technology (SWITCH).

ACCESS Health United States



The United States office of ACCESS Health has continued to publish critical and timely information on all aspects of Covid-19 throughout 2021. Alongside numerous articles, op-eds and whitepapers and media interviews, ACCESS Health Chair and President Dr. William A. Haseltine published two new books in 2021: *Variants! The Shape-Shifting Challenge of COVID-19* and *Covid Related Post Traumatic Stress Disorder (CV-PTSD): What It Is and What To Do About It* in addition to regularly publishing new versions of the *Covid Commentaries*.

Dr. Haseltine also published a young adult version of his autobiography <u>Science as a Superpower: My Lifelong Fight Against Disease and the Heroes who</u> <u>Made it Possible</u> to inspire young people to pursue a life in science and medicine and someday make their own contributions to improve human life.
