

1.1INTRODUCTION

Access Health India (AHI) supported by Bill & Melinda Gates Foundation (BMGF) and the National Health Authority (NHA) has appointed Ernst & Young (EY) to drive the System Integrators in Digital Health (SIDH) program. The SIDH program initiative aims to facilitate the implementation and use of Electronic Medical Records (EMR) in hospitals with 10 to 200 beds located in urban and semi-urban areas of India. It seeks to create a strong ecosystem of System Integrators and create an attractive and high-growth business ecosystem for them. The SIDH program also supports the adoption of NHA's Ayushman Bharat Digital Mission (ABDM) initiative across the nation. Four locations - Jaipur, Bhopal, Bhubaneswar, and Cochin - have been identified to lead the first phase of the SIDH program.

OVERVIEW OF SIDH PROGRAM

SIDH program focuses on promoting EMR adoption in urban and semi-urban regions. EY team will provide the following support to NHA and System Integrator (SI) partners:

- 1) Develop overall SIDH program and identify SIDH locations
- 2) Select ABDM-certified EMR companies for participation in the SIDH program
- 3) Select SI in SIDH locations, based on well-defined criteria (outlined in this document)
- 4) Train SI partners on core healthcare workflows, EMR products, and EMR sales
- 5) Help them sign MoU with EMR companies
- 6) Support SI partners and EMR companies in initiating marketing and sales activities to hospitals in SIDH locations
- 7) Train SI partners for effective implementation and post-implementation support
- 8) Conduct Regular review of progress of SIDH and SI partners against milestones and KPIs
- 9) Conduct stakeholder feedback across EMR companies, SI partners and hospitals

1.2 SUBMISSION OF LOI

- PART A: Company Documentation
 - a) Registration Certificate & Years in Operation
 - b) Statutory Auditor/CA Certificate specifying the turnover for the last three years.
 - c) ITR of last 3 years
 - d) Team Strength show number of full-time employees, part-time, contract employees separately. Certificate duly attested by the HR or authorized signatory.
 - e) List of key services and approx. revenues from each service for past 12 months
 - f) Total number of active clients (clients billed in last 3 months)





- g) List of healthcare clients/hospitals and projects in the past 24 months (if any)
- h) Provide 3 client references with proof of work from the client
- PART B: SIDH Approach & Commitment
 - a) **Proposed SIDH Team:** Provide the profile of team members who will be assigned to the SIDH program from your organization. Mention time commitment (e.g., 25%, 50%, 100%) for each of the team members. Also identify a senior Team Lead, who will engage with the EY and SIDH team, including their profile.
 - b) **SIDH Experience/Capabilities:** Highlight your experience and capabilities which will be relevant for the success of the project. Also, highlight your organization's commitment and focus for this initiative (in about 200 words)
 - c) Proposed SIDH Approach: Provide an approach on how your organization will prepare for the SIDH program (in about 200 words)
